Pupil premium funding overview

1. The school has continued to honour the King Edward VI Foundation promise, in that students who are disadvantaged are supported in their learning with a commitment to provide parents with some level of autonomy in deciding how the pupil premium is allocated.

2. Pupils eligible for the funding support could claim for support in meeting the following costs:

- a. The cost of a bus or rail pass to travel to and from school.
- b. The cost of a daily meal allowances up to the value of a free school meal.
- c. The cost of the purchase of compulsory school uniform up to a value of £200 (suit, shirts, trousers, blazer & badge & tie)
- d. The cost of the purchase school sports kit e.g. shorts, shirts, socks, vest, foot wear up to a value of £100.
- e. The purchase of a pair of school shoes (black only) up to a value of £50.
- f. The purchase of an outdoor coat up to a value of £50.
- g. To purchase essential equipment and clothing required for lessons e.g. aprons for Design & Technology.
- h. To meet the cost of music tuition which takes place at the school including the hire and purchase of instruments.
- i. To meet the cost of participating on the Duke of Edinburgh Award Scheme.
- j. To meet the cost of the purchase of books and other learning resources up to a value of £200.
- k. To meet the cost of a standard rail fare to travel to university interviews.
- l. To meet the cost of examination entry fees including UCAS.
- m. To meet the cost of purchasing a computer device up to a value of £450.
- n. To put towards the requested parental contribution for an off-site visit.

Requests for items not included in the list above needed approval from the SLT.

3. The provision of support towards a bus pass, music tuition, educational visit, uniform expenditure or learning resources is contributing positively to students' learning experience at Aston. Consequently, the disadvantaged students are performing well in their final GCSE examinations, often making more good progress which is not far off than whole school average. Although only 8 but school has noticed the lower performance of AT pupils at A Level
